

BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:

The City Council Emeritus/Emerita Program was implemented on January 19, 2010 to recognize former Mayors Pro Tem and former City Councillors who continue to be leaders in the community.

WHEREAS, under the City Council *Emeritus/Emerita* Program the title of *emeritus/emerita* may be conferred upon former Mayors Pro Tempore and former City Councillors to commemorate their contributions to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF LAS CRUCES:




The City Council Emeritus/Emerita Program

Guidelines for Recognizing Former City of Las Cruces Elected Officials

The following guidelines shall be followed regarding the recognition of former City of Las Cruces elected officials under the City Council Emeritus/Emerita Program.

- The title of *emeritus/emmerita* should appear as: Jane S. Doe, Mayor Pro Tempore *Emerita* or John S. Doe, Las Cruces City Councillor *Emeritus*.
- Former Mayors of the City of Las Cruces are excluded from the City Council *Emeritus/Emerita* Program.
- The recipient must be at least 65 years of age to participate in the City Council *Emeritus/Emerita* Program.
- The recipient of the title of *emeritus/emmerita* cannot use the City of Las Cruces logo in conjunction with the recipient's name on letterhead or business cards.
- The title of *emeritus/emmerita* cannot be used for endorsement or political purposes.
