**A RESOLUTION AUTHORIZING THE CITY OF LAS CRUCES POLICE DEPARTMENT TO ACCEPT THE SUB-GRANT AGREEMENT FOR THE FY 2010 PROJECT SAFE NEIGHBORHOODS GRANT AWARDED BY THE DEPARTMENT OF JUSTICE, THROUGH THE NEW MEXICO DEPARTMENT OF PUBLIC SAFETY IN THE AMOUNT OF \$10,000.00, TO RATIFY THE MAYOR'S SIGNATURE TO MEET GRANT AWARD DEADLINE, AND ADJUST THE FY 2010 BUDGET.**

The City Council is informed that:

**WHEREAS**, the U.S. Department of Justice, Project Safe Neighborhoods (PSN), Grant Accountability & Compliance Section, through the New Mexico Department of Public Safety has awarded the City of Las Cruces Police Department the Project Safe Neighborhoods (PSN) Grant; and

**WHEREAS**, the Las Cruces Police Department already participates in the PSN program; and

**WHEREAS**, the funding award is \$10,000.00 with no match required from the City of Las Cruces; and

**WHEREAS**, these funds will be utilized to improve or enhance local enforcement of strategies aimed at reducing gun violence and gun crime; reducing the occurrence of violent gang-related incidents; and reducing the occurrences of youth gang-related incidents and increase positive outcomes for youth.

**NOW, THEREFORE**, be it resolved by the governing body of the City of Las Cruces:

THAT, the City of Las Cruces is authorized to accept the grant on behalf of the Las Cruces Police Department from the U.S. Department of Justice, Project Safe Neighborhoods (PSN), Grant Accountability & Compliance Section, through the New Mexico Department of Public Safety; and

THAT, the Council does ratify the signature of the Mayor approving acceptance of the award to meet the grant award deadline and approve the adjustment of the FY 2010 budget to reflect the \$10,000.00 award; and
