To approve, modify, or not approve authorization for beer and wine sales at Apodaca Park during the 2011 Las Cruces Vaqueros baseball season.

BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:

The Las Cruces Vaqueros, a member of the Pecos Baseball League of Professional Baseball Clubs, has scheduled 46 home games during the 2011 season.

The Game Bar & Grill is requesting approval to sell beer and wine for consumption at the baseball games within a restricted and secured area at Apodaca Park. Approval by the City Council is required prior to submission of the Special Dispenser Permit Applications to the Alcohol and Gaming Division of the Regulation and Licensing Department of the State of New Mexico ("Alcohol and Gaming").

Final approval by Alcohol and Gaming would allow beer and wine to be sold for consumption within a restricted and secured area at Apodaca Park during the specific dates and times noted in the chart on the following page.

Alcohol and Gaming requires issuance of a Special Dispenser Permit 10 days prior to an event. In this case, the permit issuance date for the first baseball game is on or about May 1, 2011.

The City Council is informed that:

WHEREAS, the Las Cruces Vaqueros baseball team has scheduled 46 home games during the 2011 season; and

WHEREAS, The Game Bar & Grill is requesting approval to sell beer and wine for consumption within a restricted and secured area at Apodaca Park during the Las Cruces Vaqueros baseball games; and

WHEREAS, approval by the City Council is required prior to submission of the Special Dispenser Permit Applications to the Alcohol and Gaming Division of the Regulation and Licensing Department of the State of New Mexico ("Alcohol and Gaming"); and

WHEREAS, final approval by Alcohol and Gaming would allow beer and wine to be sold for consumption at the 46 scheduled home games at Apodaca Park; and
