

COUNCIL BILL NO. 12-003  
ORDINANCE NO. 2625

**AN ORDINANCE REDISTRICTING THE CITY OF LAS CRUCES' SIX (6) DISTRICTS, REDRAWING DISTRICT LINES, AND REPEALING LCMC 1997, SEC. 8-2 IN ITS ENTIRETY AND ENACTING A NEW SEC. 8-2.**

The City Council is informed that:

**WHEREAS**, Section 3-12-1.1 NMSA 1978 as amended requires that once following every federal decennial census, the governing body of a municipality shall divide the municipality into a number of districts equal to the number of members on the governing body; and

**WHEREAS**, the LCMC 1997 (Charter), Section 2.01(e), adopted and approved by the voters of the City of Las Cruces provides that:

*District boundaries and revisions.* The council shall, be (by) ordinance, set the boundaries of each district. These boundaries shall remain in effect until altered or changed by the council by ordinance. In establishing the district boundaries, the council shall consider the following principles which, in the event of any conflict among them, shall be considered in the following order:

1. Each district shall contain as nearly as possible substantially the same population based upon the most recent federal census.
2. Communities of interest, including those based upon ethnic and economic factors, shall be preserved whenever reasonable within a single district.
3. Each district shall be formed of compact, contiguous territories. The total length of all district boundary lines shall be as short as possible; and

**WHEREAS**, Research & Polling, Inc. has a professional service agreement with the City of Las Cruces dated January 4, 2011, to prepare and complete various redistricting proposals for the City Council's adoption on or before June 30, 2011; and

**WHEREAS**, to assist the City Council in the evaluation of various proposals the City Council created a Citizens Ad Hoc Committee to assist Research & Polling, Inc. to evaluate the various proposals.

**NOW, THEREFORE**, Be it ordained the governing body of the City of Las Cruces:

(I)

**THAT** the current LCMC 1997, Sec. 8-2, "District boundaries established" be repealed in its entirety.

(II)


**THAT** a new LCMC 1997, Sec. 8-2, "District boundaries established", is hereby enacted as shown in Exhibit  A , attached hereto and made part of this Ordinance.

(III)

**THAT** City staff is hereby authorized to do all deeds necessary in the accomplishment of the herein above.

Sec. 8-2 District boundaries established.

Districting Plan F2 attached to Ordinance No. 2625 and incorporated herein by reference, is adopted for the purposes of redrawing the district boundaries of each of the City of Las Cruces' six (6) districts. The boundaries of the districts shall be as follows:

**DISTRICT 1**

The boundaries of District 1 shall consist of precincts 20, 26, 27, 28, 29, 30, 31, 32, 35, 36, 37, 89, 92, and 99. Precinct designations and boundaries are those in effect as of May 31, 2011.

Beginning at the intersection of Amador Avenue (NM 342) and the BNSF Railroad, East on Amador Avenue (NM 342) to Solano Drive, North on Solano Drive to Spruce Avenue, East on Spruce Avenue to Evelyn Street, North on Evelyn Street to Madrid Avenue, East on Madrid Avenue to Fairbanks Drive, North on Fairbanks Drive to Fairfax Avenue, East on Fairfax Avenue to Triviz Drive, North then West on Triviz Drive to Elks Drive, North on Elks Drive to Lavender Drive, North on Lavender Drive to McCoy Avenue, West on McCoy Avenue to Holiday Lane, North on Holiday Lane to the City Limits, Southwest on the City Limits to Doña Ana Drain, South on Doña Ana Drain to Government Dam Drain, East on Government Dam Drain to El Camino Real Road, Southeast on El Camino Real to Main Street (US 70), South on Main Street (US 70) to Madrid Avenue, West on Madrid Avenue to Las Cruces Lateral, Northwest on Las Cruces Lateral to Alameda Boulevard, South on Alameda Boulevard to Santa Monica Drive, West on Santa Monica Drive to BNSF Railroad, and South on the railroad tracks to Amador Avenue (NM 342).

**DISTRICT 2**

The boundaries of District 2 shall consist of precincts 7, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58, 71, 72, 73, 77, 78, 104, 114, and a portion of precinct 113. Precinct designations and boundaries are those in effect as of May 31, 2011.

All of the area within the City, from the intersection of University Avenue and the western City Limits, Southeast then North on the City Limits to Imperial Ridge Street, West on Imperial Ridge Street to Enchanted Drive, North on Enchanted Drive to Missouri Avenue, Southwest on Missouri Avenue to Solano Drive, North on Solano Drive to Boutz Road, West on Boutz Road to the BNSF Railroad tracks, South on the

railroad tracks to the Park Drain, West on the Park Drain to the City Limits, and Southeast on the City Limits to University Avenue.

**DISTRICT 3**

The boundaries of District 3 shall consist of precincts 33, 34, 42, 43, 44, 45, 46, 47, 48, 68, 70, 91, 93, and 94. Precinct designations and boundaries are those in effect as of May 31, 2011.

Beginning at the intersection of Boutz Road and the BNSF Railroad tracks, East on Boutz Road to Solano Drive, South on Solano Drive to Missouri Avenue, Northeast on Missouri Avenue to Candeleras Street, Northwest on Candeleras Street to Hillrise Drive, South on Hillrise Drive to Executive Hills Road, West on Executive Hills Road to Hillrise Drive, West on Hillrise Drive to Telshor Boulevard, North on Telshor Boulevard to Lohman Avenue, West on Lohman Avenue to Triviz Drive, North on Triviz Drive to Fairfax Avenue, West on Fairfax Avenue to Fairbanks Drive, South on Fairbanks Drive to Madrid Avenue, West on Madrid Avenue to Evelyn Street, South on Evelyn Street to Spruce Avenue, West on Spruce Avenue to Solano Drive, South on Solano Drive to Amador Avenue, West on Amador Avenue to Esperanza Street, South on Esperanza Street to Utah Avenue, West on Utah Avenue to Mesquite Street, South on Mesquite Street to Idaho Avenue, West on Idaho Avenue to El Paseo Road, North on El Paseo Road to Wyatt Drive, West on Wyatt Drive to Main Street (NM 478), South on Main Street (NM 478) to Idaho Avenue, West on Idaho Avenue to the BNSF Railroad tracks, and South on the railroad tracks to Boutz Road.

**DISTRICT 4**

The boundaries of District 4 shall consist of precincts 19, 22, 23, 24, 25, 38, 39, 40, 41, 84, 88, 90, 107, and 108. Precinct designations and boundaries are those in effect as of May 31, 2011.

Beginning at the intersection of the western City Limits and the Park Drain, East on the Park Drain to the BNSF Railroad tracks, North on the railroad tracks to Idaho Avenue, East on Idaho Avenue to Main Street (NM 478), North on Main Street (NM 478) to Wyatt Drive, East on Wyatt Drive to El Paseo Road, South on El Paseo Road to Idaho Avenue, East on Idaho Avenue to Mesquite Street, North on Mesquite Street to Utah Avenue, East on Utah Avenue to Esperanza Street, North on Esperanza Street to Amador Avenue, West on Amador Avenue (becomes NM 342 at Main Street) to the BNSF Railroad tracks, North on railroad tracks to Santa Monica Drive, East on Santa

Monica Drive to Alameda Boulevard, North on Alameda Boulevard to Las Cruces Lateral, Southeast on Las Cruces Lateral to Madrid Avenue, East on Madrid Avenue to Main Street (US 70) City, North on Main Street (US 70) to El Camino Real, Northwest on El Camino Real to Government Dam Drain, West on Government Dam Drain to Doña Ana Drain, North on Doña Ana Drain to City Limits and South on City Limits to the Park Drain.

**DISTRICT 5**

The boundaries of District 5 consist of precincts 61, 62, 65, 83, 85, 105, 109, and a portion of precinct 59. Precinct designations and boundaries are those in effect as of May 31, 2011.

Beginning at the intersection of Main Street (US 70) and Elks Drive, Northeast on Main Street (US 70) to the City Limits, North on the City Limits to the North Limits then generally West on the City Limits to Holiday Lane, Holiday Lane South to McCoy Avenue, East on McCoy Avenue to Lavender Drive, South on Lavender Drive to Elks Drive, South on Elks Drive to Main Street (US 70).

**DISTRICT 6**

The boundaries of District 6 consist of precincts 66, 67, 69, 102, 103, 106, 112, a portion of precinct 59 and a portion of precinct 113. Precinct designations and boundaries are those in effect as of May 31, 2011.

Beginning at the intersection of Lohman Avenue and Triviz Drive, East on Lohman Avenue to Telshor Boulevard, South on Telshor Boulevard to Hillrise Drive, East on Hillrise Drive to Executive Hills Road, East on Executive Hills Road to Hillrise Drive, North on Hillrise Drive to Candeleras Street, Southeast on Candeleras Street to Missouri Avenue, Southwest on Missouri Avenue to Enchanted Drive, South on Enchanted Drive to Imperial Ridge Street, East on Imperial Ridge Street to the City Limits, Northeast on City Limits to Main Street (US 70), Southwest on Main Street (US 70) to Elks Drive, South on Elks Drive to Triviz Drive, East on Triviz Drive and then South on Triviz Drive to Lohman Avenue.

Districting Plan F3 attached to Ordinance No. 2625 and incorporated herein by reference, is adopted for the purposes of redrawing the district boundaries of each of the City of Las Cruces' six (6) districts. The boundaries of the districts shall be as follows:

**DISTRICT 1**

The boundaries of District 1 shall consist of precincts 20, 24, 25, 28, 29, 30, 31, 32, 35, 36, 37, 41, 84, 89, 92, 99. Precinct designations and boundaries are those in effect as of May 31, 2011.

Beginning at the intersection of Amador Avenue (NM 342) and Water Street, East on Amador Avenue (NM 342) to Main Street, South on Main Street to Wyatt Drive, East on Wyatt Drive to El Paseo Road, South on El Paseo Avenue to Idaho Road, East on Idaho Avenue to Mesquite Street, North on Mesquite Street to Utah Avenue, East on Utah Avenue to Esperanza Street, North on Esperanza Street to Amador Avenue, East on Amador Avenue to Solano Drive, North on Solano Drive to Spruce Avenue, East on Spruce Avenue to Kilmer Street, North on Kilmer Street to Ash Avenue, West on Ash Avenue to Calle Sosa, North on Calle Sosa to Mulberry Avenue, East on Mulberry Avenue to Sexton Street, North on Sexton Street to Madrid Avenue, East on Madrid Avenue to Solano Drive, North on Solano Drive to Madrid Avenue, East on Madrid Avenue to Main Street, North on Main Street to Elks Drive, North on Elks Drive to Lavender Drive, North on Lavender Drive to McCoy Avenue, West on McCoy Avenue to Holiday Lane, North on Holiday Lane to the City Limits, South and West on the City Limits to the BNSF Railroad, South on the railroad tracks to Amador Avenue, East on Amador Avenue to Water Street.

All of the area within the City, from the intersection of University Avenue and the western City Limits, the City Limits to Imperial Ridge Street, West on Imperial Ridge Street to Enchanted Drive, North on Enchanted Drive to Missouri Avenue, East on Missouri Avenue to Solano Drive, North on Solano Drive to Boutz Road, West on Boutz

Road to the BNSF Railroad tracks, South on the railroad tracks to the Park Drain, West on the Park Drain to the City Limits, Southwest on the City Limits to University Avenue.

**DISTRICT 3**

The boundaries of District 3 shall consist of precincts 26, 27, 33, 34, 42, 43, 44, 45, 46, 68, 70, 91, 93, and 94. Precinct designations and boundaries are those in effect as of May 31, 2011.

Beginning at the intersection of Utah Avenue and Esperanza Street, East on Utah Avenue to Luna Street, South on Luna Street to Bellamah Drive, East on Bellamah Drive to Locust Street, South on Locust Street to Calle de Suenos, East on Calle de Suenos to Walden Drive, South on Walden Drive to Missouri Avenue, Northeast on Missouri Avenue to Candeleras Street, North on Candeleras Street to Hillrise Drive, West on Hillrise Drive to Telshor Boulevard, North on Telshor Boulevard to Lohman Avenue, West on Lohman Avenue to Triviz Drive, North on Triviz Drive to Main Street, West on Main Street to Madrid Avenue, East on Madrid Avenue to Solano Drive, South on Solano Drive to Madrid Avenue, East on Madrid Avenue to Sexton Street, South on Sexton Street to Mullberry Avenue, East on Mullberry Avenue to Calle Sosa, South on Calle Sosa to Ash Avenue, East on Ash Avenue to Kilmer Street, South on Kilmer Street to Spruce Avenue, West on Spruce Avenue to Solano Drive, South on Solano Drive to Amador Avenue, West on Amador Avenue to Esperanza Street, South on Esperanza Street to Utah Avenue.

Beginning at the intersection of the western City Limits and the Park Drain, East on the Park Drain to the BNSF Railroad tracks, North on the railroad tracks to Boutz Road, East on Boutz Road to Solano Drive, South on Solano Drive to Missouri Avenue, East on Missouri Avenue to Walden Drive, North on Walden Drive to Calle de Suenos, West on Calle de Suenos to Locust Street, North on Locust Street to Bellamah Drive, West on Bellamah Drive to Luna Street, North on Luna Street to Utah Avenue, West on Utah Avenue to Mesquite Street, South on Mesquite Street to Idaho Avenue, West on Idaho Avenue to El Paseo Road, North on El Paseo Road to Wyatt Drive, West on Wyatt Drive to Main Street, North on Main Street to Amador Avenue, West on Amador Avenue

to the BNSF Railroad tracks, North on BNSF Railroad tracks to the City Limits, West and South on City Limits to the Park Drain.

**DISTRICT 5**



Beginning at the intersection of Main Street (US 70) and Elks Drive, Northeast on Main Street (US 70) to the City Limits, North on the City Limits to the North Limits then generally West on the City Limits to Holiday Lane, South on Holiday Lane to McCoy Avenue, East on McCoy Avenue to Lavender Drive, South on Lavender Drive to Elks Drive, South on Elks Drive to Main Street (US 70).

**DISTRICT 6**




West's New Mexico Statutes Annotated Currentness

Chapter 3. Municipalities

▣ Article 12. Governing Body of Municipality

→ § 3-12-1.1. Election of members of governing bodies; requiring residency

Except as provided in Section 3-12-2 NMSA 1978, members of governing bodies, excluding mayors, of municipalities having a population in excess of ten thousand shall reside in and be elected from single-member districts. If any member of the governing body permanently removes his residence from or maintains no residence in the district from which he was elected, he shall be deemed to have resigned. Once, following every federal decennial census, the governing body of the municipality shall divide the municipality into a number of districts equal to the number of members on the governing body. Such districts shall be compact and contiguous and composed of populations as nearly equal as practicable; provided that the governing body of H class counties and of any municipality having a population of ten thousand or less may provide for single-member districts as provided in this section.



### BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:

Research & Polling, Inc. held work session meetings with the Las Cruces City Council on February 14, 2011, April 11, 2011 and May 9, 2011, which included handouts. During the April 11, 2011, work session, five plans were presented to council. At the May 9, 2011, work session, Research & Polling, Inc. presented the council with two additional plans. There was council consensus to bring forward Plan F. Public input was received through these three meetings. The video recordings of these meetings can be viewed on [clctv.com](http://clctv.com).

On February 22, 2011, council created the Redistricting Ad-Hoc Committee to assist Research & Polling, Inc. to evaluate the various proposals. The committee's meeting minutes of March 30, 2011 and April 19, 2011 were forwarded to Research & Polling, Inc. for consideration as stated in Resolution No. 11-181.

On June 6, 2011, after a two hour city council work session and a regular city council meeting, the city council directed Research & Polling, Inc. to create a variation on proposed redistricting plans F and F-1 and have city staff bring it to city council on June 20, 2011 for first reading.

The various redistricting plans compiled by Research & Polling, Inc. after public input are described as Plans A, B, C, D, E, F, F-1, and G, all of which have been and are on public display in the lobby area at City Hall.

In order to adopt an election resolution for the November 8, 2011 election, a redistricting plan is required to be adopted no later than July 5, 2011.
