BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:

The Office of National Drug Control Policy has awarded the City of Las Cruces \$791,896.00 for Fiscal Year 2011-2012 to support the Regional Interagency Drug Task Force and the Warren Reese Southern New Mexico High Intensity Drug Trafficking Area (HIDTA) Law Enforcement Center at the Southwest Border of the Southwest District of New Mexico HIDTA. The City will act as fiscal agent on behalf of HIDTA for the award designated as Grant No. G11SN0006A. Funding will be used for the following:

- Overtime for Dona Ana County Sheriff's Office agents assigned to Metro in the amount of \$14,027.00;
- Salary and benefits of both a full-time HIDTA accounting technician and a full-time data entry clerk; overtime, travel, services, equipment, supplies and miscellaneous expenses of the Las Cruces Police Department agents assigned to Metro in the amount of \$154,976.00;
- Yearly rent for the Regional Interagency Drug Task Force in the amount of \$181,987.00;
- Overtime, travel and services for New Mexico State Police agents assigned to Metro in the amount of \$28,328.00;
- Overtime for Fugitive/Violent Offender Task Force in the amount of \$10,080.00;
- Yearly rent for Management and Coordination (Town of Mesilla) in the amount of \$114,900.00;
- Yearly rent for New Mexico Department for Public Safety Crime Lab in the amount of \$106,228.00; and
- Yearly rent for New Mexico Investigative Support Center in the amount of \$181,370.00.

RESOLUTION NO. 12-012**A RESOLUTION AUTHORIZING THE CITY OF LAS CRUCES TO ACCEPT A GRANT AWARD IN THE AMOUNT OF \$791,896.00 FROM THE OFFICE OF NATIONAL DRUG CONTROL POLICY AND TO ADJUST FISCAL YEAR 2012 ADOPTED BUDGET.**

The City Council is informed that:

WHEREAS, the Office of National Drug Control Policy has awarded the City of Las Cruces \$791,896.00 to support the Regional Interagency Drug task Force and the Warren Reese Southern New Mexico High Intensity Drug Trafficking Area (HIDTA) Law Enforcement Center (Center); and

WHEREAS, the City will be the recipient of the award designated as Grant No. G11SN0006A, and will act as the fiscal agent for the award on behalf of HIDTA; and

WHEREAS, the award will pay the yearly rent for the Center in the amount of \$584,485.00; salary and benefits of a full-time HIDTA accounting technician and data entry clerk in the amount of \$70,000.00; overtime travel, services, supplies and miscellaneous expenses for the Las Cruces Police Department, Doña Ana County and New Mexico State Police personnel in the amount of \$127,331.00; and overtime for Fugitive/Violent Offender Task Force personnel in the amount of \$10,080.00; and

WHEREAS, because HIDTA funding cannot be used to pay fiscal agent administrative fees, HIDTA hired a part-time financial clerk in November 1999 to perform administrative duties related to all HIDTA grants, thereby relieving those duties from Las Cruces Police Department staff; and

WHEREAS, the City and HIDTA will comply with the HIDTA Grant Agreement with Special Conditions and will not use funds from the grant award to supplant state or local funds that would otherwise be made available for support of the Center's initiatives.

NOW, THEREFORE, Be it resolved by the governing body of the City of Las Cruces:



The Office of National Drug Control Policy is awarding funds to the NM HIDTA Program to support various HIDTA Initiatives. Your fiduciary was awarded the funds as outlined in the attached grant award and supplement to support the Strategy of the HIDTA program.
