**TITLE:** A RESOLUTION AUTHORIZING THE GAME SPORTS BAR & GRILL TO CONTINUE WITH THE PERMITTING PROCESS TO ALLOW FOR THE SALE AND CONSUMPTION OF BEER AND WINE WITHIN A RESTRICTED AND SECURED AREA AT APODACA PARK, 801 EAST MADRID, LAS CRUCES, NEW MEXICO, DURING THE 2012 LAS CRUCES VAQUEROS BASEBALL SEASON.

**PURPOSE(S) OF ACTION:**

To approve, modify, or not approve the sale of beer and wine at Las Cruces Vaqueros baseball games.

**BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:**

The Las Cruces Vaqueros baseball team, a member of the Pecos League of Professional Baseball Clubs, has scheduled 31 home games during the 2012 season.

The Game Sports Bar & Grill is requesting approval to sell beer and wine for consumption at the home games within a restricted and secured area at Apodaca Park. Approval by the City Council is required prior to submission of the Special Dispenser Permit Applications to the Alcohol and Gaming Division of the Regulation and Licensing Department of the State of New Mexico ("Alcohol and Gaming").

Final approval by Alcohol and Gaming would allow beer and wine to be sold for consumption within a restricted and secured area at Apodaca Park on the 31 game days listed under Support Information on the following page. Hours of service on each day will begin at 5:00 p.m. and end at 11:00 p.m.

Approval of the Special Dispenser Permit Applications will also comply with the requirements of the Las Cruces Municipal Code, Section 5-1, which restricts alcohol consumption in public places to areas approved by Alcohol and Gaming only.

**A RESOLUTION AUTHORIZING THE GAME SPORTS BAR & GRILL TO CONTINUE WITH THE PERMITTING PROCESS TO ALLOW FOR THE SALE AND CONSUMPTION OF BEER AND WINE WITHIN A RESTRICTED AND SECURED AREA AT APODACA PARK, 801 EAST MADRID, LAS CRUCES, NEW MEXICO, DURING THE 2012 LAS CRUCES VAQUEROS BASEBALL SEASON.**

The City Council is informed that:

**WHEREAS**, the Las Cruces Vaqueros baseball team has scheduled 31 home games during the 2012 season; and

**WHEREAS**, The Game Sports Bar & Grill is requesting approval to sell beer and wine for consumption within a restricted and secured area at Apodaca Park during the Las Cruces Vaqueros baseball games as noted on Exhibits "A" through "EE"; and

**WHEREAS**, approval by the City Council is required prior to submission of the Special Dispenser Permit Applications to the Alcohol and Gaming Division of the Regulation and Licensing Department of the State of New Mexico ("Alcohol and Gaming"); and

**WHEREAS**, final approval by Alcohol and Gaming would allow beer and wine to be sold for consumption at the 31 scheduled home baseball games at Apodaca Park; and

**WHEREAS**, approval of the Special Dispenser Permits will also comply with the requirements of the Las Cruces Municipal Code, Section 5-1, which restricts alcohol consumption in public to areas approved by Alcohol and Gaming only.
