**BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:**

Keep Las Cruces Beautiful in partnership with the Parks and Recreation Department has solicited the art community for volunteers to design and paint murals throughout the community. The current mural located at the north end of the Triviz pathway has suffered graffiti/vandalism and the artist would like to paint over her existing art work.

The vision for the new mural was developed by local artist, Denali Wilson and is focusing on a segment of the local culture and their separation from Mexico. Multiple artists from NMSU will contribute to the work. This matter was discussed before the Parks and Recreation Board on July 21, 2012 and was approved.

Keep Las Cruces Beautiful will provide paint, brushes and other supplies to complete the mural.

**WHEREAS**, Keep Las Cruces Beautiful in partnership with the Parks and Recreation Department solicited the art community for volunteers to design and paint murals throughout the community; and

**WHEREAS**, the mural that was painted at the North end of the Triviz pathway has suffered some graffiti/vandalism and the original artist would like to paint over the existing work; and

**WHEREAS**, the concept for the Triviz underpass mural will be painted by local artist, Denali Wilson and the vision will be focused on a segment of our local culture and their respective separation from Mexico; and

**WHEREAS**, multiple artists from NMSU will contribute to the work; and
