

**BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:**

On July 1, 2013, City Council increased the time required to post and issue notices to the public from at least 24 hours prior to a meeting to at least 72 hours as required by the Open Meetings Act (OMA).

This ordinance will amend another section in the Las Cruces Municipal Code, which also made reference to issuing and posting notices for boards from at least 24 hours prior to any regular or special meeting to at least 72 hours prior as required by OMA.

**ORDINANCE NO.** 2691

**AN ORDINANCE AMENDING THE LAS CRUCES MUNICIPAL CODE, SECTION 2-189(B)(3) CONCERNING MEETINGS FOR BOARDS.**

The City Council is informed that:

**WHEREAS**, House Bill 21 amended the Open Meetings Act (OMA) to increase the time that a public body must make the final agenda available from at least 24 hours prior to a meetings to at least 72 hours, except in the case of an emergency (as defined in the existing Act as matters arising from unforeseen circumstances that if not addressed immediately will likely result in injury, damage to persons or property, or substantial financial loss to the public body). For public bodies that ordinarily meet more frequently than once a week, a draft agenda must be posted at least 72 hours prior to the meeting and final agenda be posted 36 hours prior to the meeting;

**WHEREAS**, the bill also requires the agenda be posted on the public body's website within the specified time periods if a website is maintained;

**WHEREAS**, House Bill 21 went into effect on June 14, 2013;

**WHEREAS**, City Council has amended the Las Cruces Municipal Code to change the time requirements for posting their notices and agendas; and

**WHEREAS**, City boards, committees and commissions shall have the same requirements for posting their agendas.

**NOW, THEREFORE**, Be it ordained by the governing body of the City of Las Cruces:

**(I)**

**THAT** LCMC 1997, Section 2-189(b)(3) is amended to read as follows:

Notice shall include the issuance and posting of an agenda for regular meetings at least 72 hours prior to any regular board meeting. Notice for special meetings shall require the issuance and posting of an agenda at least 72 hours before the special meeting. At least once a year, in January, each public board, commission, or committee shall determine what is public notice. In no event shall notice be less than the notice required for city council meetings.

(II)

THAT City staff is hereby authorized to do all deeds necessary in the accomplishment of the herein above.
