**BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:**

The City of Las Cruces has approximately 550 lane miles of paved roadway within the city limits. Approximately 280 lane miles of those paved roads have painted striping. The Streets and Traffic Operations Section of the City of Las Cruces Transportation Department maintains the roadway striping throughout the city. The road striping is utilized to provide safer direction and information for motorists, bicyclists and pedestrians. The section's goal is to restripe all streets twice a year and restripe as many arterial roadways a third time as funding allows.

If the road striping is not regularly maintained, then existing striping could become worn and less visible which could lead to unsafe conditions on city roadways. Additionally, changes may be needed to existing striping to provide guidance improvements for safety, and information throughout the city.

The State of New Mexico has issued Pricing Agreement Number 40-805-13-10335 to San Bar Construction Corporation of Albuquerque, New Mexico for road striping. The Transportation Department has reviewed the agreement, and has requested to utilize this agreement. A list of streets in need of striping maintenance is attached as Attachment A.

The Transportation Department recommends that the Council award the contract for the 2014/2015 Road Striping Maintenance to San Bar Construction Corporation in the amount of \$209,777.54 plus \$16,651.09 for New Mexico Gross Receipts Tax for a total project cost of \$226,428.63.

1. Vote "Yes"; this will approve the Resolution awarding a contract for the Fiscal Year 2014/2015 Road Striping Maintenance to San Bar Construction Corporation of Albuquerque, New Mexico in the amount of \$209,777.54 plus \$16,651.09 for New Mexico Gross Receipts Tax for a total project cost of \$226,428.63. This will allow road striping maintenance to be contracted to meet operational needs.
2. Vote "No"; this action will reject the proposed contract and instruct staff to either re-bid, re-scope or abandon the contract all together. Without this contract, the ability to procure services for striping will be less efficient and potentially more costly.

**A RESOLUTION AWARDED A CONTRACT FOR ROAD STRIPING MAINTENANCE TO SAN BAR CONSTRUCTION CORPORATION OF ALBUQUERQUE, NEW MEXICO FOR STRIPING MAINTENANCE SERVICES FOR THE FISCAL YEAR 2014/2015 IN THE AMOUNT OF \$209,777.54 PLUS \$16,651.09 FOR NEW MEXICO GROSS RECEIPTS TAX, FOR A TOTAL PROJECT COST IN THE AMOUNT OF \$226,428.63.**

The City Council is informed that:

**WHEREAS**, the Streets and Traffic Operations Section of the City of Las Cruces Transportation Department has identified City paved roadways in need of road striping maintenance; and

**WHEREAS**, the State of New Mexico has issued Pricing Agreement Number 40-805-13-10335 to San Bar Construction Corporation of Albuquerque, New Mexico for road striping; and

**WHEREAS**, the Transportation Department has reviewed the agreement, and has requested to utilize the agreement to perform the road striping maintenance of City streets; and

**WHEREAS**, the Transportation Department recommends award to San Bar Construction Corporation of Albuquerque, New Mexico in the amount \$209,777.54; and

**WHEREAS**, the project will consist of reapplying paint to existing stripes on various roads as well as painting stripes to recently resurfaced roads throughout the City.

**NOW, THEREFORE**, Be it resolved by the governing body of the City of Las Cruces:

**(I)**

**THAT** the Fiscal Year 2014/2015 Road Striping Maintenance Project is hereby

awarded to San Bar Construction Corporation of Albuquerque, New Mexico in the amount of \$209,777.54 plus \$16,651.09 for New Mexico Gross Receipts Tax to maintain the striping of roads throughout the City.

THAT the Purchasing Manager is authorized to contract with San Bar Construction Corporation of Albuquerque, New Mexico as outlined in the Exhibit "A", Purchasing Manager's Request to Contract Form.

THAT the City staff is hereby authorized to do all deeds necessary in the accomplishment of the herein above.




