

TITLE: A RESOLUTION AUTHORIZING BOSQUE BREWING CO. TO CONTINUE WITH THE PERMITTING PROCESS TO ALLOW FOR THE SALE AND CONSUMPTION OF BEER WITHIN A RESTRICTED AND SECURED AREA AT THE 1ST ANNUAL LAS CRUCES CHILE DROP TO BE HELD ON MAIN STREET ON DECEMBER 31, 2014.

BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:

Project Mainstreet is the sponsor of the 1st Annual Las Cruces Chile Drop to be held on December 31, 2014 on Main Street, generally between Las Cruces Avenue and Griggs Avenue. Bosque Brewing Co. is requesting approval to sell beer for consumption within a restricted and secured area during the event.

Approval by the Las Cruces City Council is required prior to the submission of the Public Celebration Permit Application to the Alcohol and Gaming Division of the Regulation and Licensing Department of the State of New Mexico ("Alcohol and Gaming"). Final approval by Alcohol and Gaming would allow Bosque Brewing Co. to sell beer within the restricted and secured area between 7:00 p.m. and 1:00 a.m. on December 31, 2014.

The authorization of the Public Celebration Permit Application will comply with the requirements of the Las Cruces Municipal Code, Section 5-1, which restricts alcohol consumption in public places to areas approved by Alcohol and Gaming only.

WHEREAS, final approval by Alcohol and Gaming would allow Bosque Brewing Co. to sell beer for consumption within a restricted and secured area during the event; and

WHEREAS, approval of the Public Celebration Permit Application will comply with the requirements of the Las Cruces Municipal Code, Section 5-1, which restricts alcohol consumption in public to areas approved by Alcohol and Gaming only.

NOW, THEREFORE, Be it resolved by the governing body of the City of Las Cruces:

allow beer to be sold for consumption within a restricted and secured area between 7:00 p.m. and 1:00 a.m. on December 31, 2014.




