BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:

The City of Las Cruces, through its Convention and Visitors Bureau, will present the Las Cruces Country Music Festival ("Music Festival") April 24-26, 2015 in the Downtown area.

The Game Sports Bar & Grill is requesting approval to sell alcoholic beverages for consumption on April 24th and 25th, 2015 from 5:00 p.m. to 11:30 p.m. on each day. Approval by the Las Cruces City Council is required prior to submission of the Special Dispenser Permit Application to the Alcohol and Gaming Division of the Regulation and Licensing Department of the State of New Mexico ("Alcohol and Gaming"). Final approval by Alcohol and Gaming would allow alcoholic beverages to be sold for consumption at two separate bars within restricted and secured areas. A site plan is attached as Attachment "1".

Approval of the Special Dispenser Permit Applications will also comply with the requirements of the Las Cruces Municipal Code, Section 5-1, which restricts alcohol consumption in public places to areas approved by Alcohol and Gaming only.

The City Council is informed that:

WHEREAS, the Las Cruces Country Music Festival ("Music Festival") will be held at Downtown, April 24-26, 2015; and

WHEREAS, The Game Sports Bar & Grill is requesting approval to sell alcoholic beverages for consumption on April 24th and 25th, 2015 at two separate bars within restricted and secured areas during the Music Festival; and

WHEREAS, approval by the City Council is required prior to submission of the Special Dispenser Permit Application to the Alcohol and Gaming Division of the Regulation and Licensing Department of the State of New Mexico ("Alcohol and Gaming"); and

WHEREAS, final approval by Alcohol and Gaming would allow alcoholic beverages to be sold for consumption during the Music Festival; and

WHEREAS, approval of the Special Dispenser Permit Application will also comply with the requirements of the Las Cruces Municipal Code, Section 5-1, which restricts alcohol consumption in public to areas approved by Alcohol and Gaming only.

NOW, THEREFORE, Be it resolved by the governing body of the City of Las Cruces:

THAT The Game Sports Bar & Grill is hereby authorized to continue with the permitting process to allow for the sale and consumption of alcoholic beverages at two

separate bars within restricted and secured areas on April 24th and 25th, 2015 during the Las Cruces Country Music Festival, as shown on Exhibit "A" attached hereto.



