**TITLE:**    A RESOLUTION DESIGNATING POLLING PLACES AND ELECTION OFFICIALS FOR THE REGULAR MUNICIPAL ELECTION TO BE HELD IN THE CITY OF LAS CRUCES, NEW MEXICO, ON TUESDAY, NOVEMBER 3, 2009.

**PURPOSE(S) OF ACTION:** To designate polling places and elections officials for the November 3, 2009 Municipal Election.

**BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:**

According to Section 3-8-19(C) NMSA 1978, precinct workers are required to be appointed by the City no less than 35 days prior to an election. Alternates can be selected to replace any precinct board member that may not be able to work on Election Day. According to Sec. 8-5 LCMC, an Absentee Board is required to be appointed by the City Council.

According to Section 3-8-19(F) NMSA 1978, compensation shall be set by the governing body. Regular precinct workers who work only on Election day; the Presiding Judge is to receive \$150.00, and all other workers will receive \$120.00 for their 14 hour day. On the Absentee Precinct Board, temporary employees, Presiding Judge is to receive \$8.50 per hour, and the remainder of the board is to receive \$7.50 per hour.

Pursuant to Section 3-8-30 NMSA 1978, the municipal clerk shall publish the names of the candidates for each office to be filled, the order their names will appear on the ballot, the location and address of the polling places for each precinct and the names of all precinct board members to which they are appointed. Publication shall be once each week for two successive weeks and is scheduled to be published 10-11-09 and 10-18-09 with Las Cruces Sun News and 10-09-09 and 10-16-09 with Las Cruces Bulletin.

**RESOLUTION NO. 10-101****A RESOLUTION DESIGNATING POLLING PLACES AND ELECTION OFFICIALS FOR THE REGULAR MUNICIPAL ELECTION TO BE HELD IN THE CITY OF LAS CRUCES, NEW MEXICO, ON TUESDAY, NOVEMBER 3, 2009.**

The City Council is informed that:

**WHEREAS**, the City Council of the City of Las Cruces, New Mexico, has called the Regular Municipal Election for Tuesday, November 3, 2009; and

**WHEREAS**, New Mexico State Law requires that the Council designate polling places and election officials for the conduct of any election; and

**WHEREAS**, polling places have been designated and election officials have been selected for this election, a listing of which is attached hereto and marked Exhibit "A".

**NOW, THEREFORE**, the City Council of the City of Las Cruces, New Mexico, resolves as follows:

**(I)**

**THAT** Exhibit "A" attached hereto, which designates the election officials and polling places to be used in the November 3, 2009, Regular Municipal Election, is hereby approved.

**(II)**

**THAT** the qualified voters within the municipal boundaries can vote by absentee or in person at the designated polling place as set out in Exhibit "A".

**(III)**

**THAT** election officials compensation is established at \$150.00 a day for Presiding Judges and \$120.00 a day for all other election officials, except for the

Absentee Precinct Board, the Presiding Judge to receive \$8.50 per hour and all other Absentee Precinct Board members to receive \$7.50 per hour.
