

**BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:**

According to NMSA 1978, Section 60-6B-10, no license shall be issued for the sale of alcoholic beverages at a licensed premises that is within 300 feet of a church or school. However, in 1997 the statute was amended to allow for the granting of a waiver of the distance restriction by the governing body of the local option district.

Project Mainstreet is sponsoring the Spirit of '45 Veterans' Tribute Dinner to be held on Main Street, generally between Las Cruces Avenue and Griggs Avenue, on August 14, 2015. The Casa De Alabanza Church is within the 300 foot distance from a designated alcoholic beverage service area located near the intersection of Main Street and Griggs Avenue.

Rio Grande Vineyards & Winery has submitted a Public Celebration Permit Application to provide wine for sale and consumption on August 14, 2015 from 6:00 p.m. to 10:00 p.m. The Alcohol and Gaming Division of the Regulation and Licensing Department requires a waiver of the church/school distance restriction by the City Council for the Public Celebration Permit Application to be approved.

The Public Celebration Permit Application is presented as a separate agenda item and approval is contingent upon approval of a waiver of the church/school distance restriction.

**WHEREAS**, Project Mainstreet is sponsoring the Spirit of '45 Veterans' Tribute Dinner, to be held on Main Street, generally between Las Cruces Avenue and Griggs Avenue on August 14, 2015; and

**WHEREAS**, the Casa De Alabanza Church is within the 300 foot distance from a designated alcoholic beverage service area near the intersection of Main Street and Griggs Avenue; and

**WHEREAS**, Rio Grande Vineyards & Winery has submitted a Public Celebration Permit Application to provide wine for sale and consumption during the Spirit of '45 Veterans' Tribute Dinner; and

**WHEREAS**, the Alcohol and Gaming Division of the New Mexico State Regulation and Licensing Department requires a waiver of the church/school distance restriction from the Las Cruces City Council for the Public Celebration Permit Application to be approved for the event; and

**WHEREAS**, granting a waiver of the church/school distance restriction will allow the applicant to proceed to the next step of the application process.

**NOW, THEREFORE,** Be it resolved by the governing body of the City of Las

Cruces:

**(I)**

**THAT** the issuance of a waiver of the church/school distance restriction to Rio Grande Vineyards & Winery for the Spirit of '45 Veterans' Tribute Dinner to be held on Main Street on August 14, 2015, as shown on Exhibit "A" attached hereto, is hereby approved.





# ZONING/VICINITY MAP



Distance to nearest church: ~50 Feet



Project Mainstreet is sponsoring the Spirit of '45 Veterans' Tribute Dinner on Main Street, generally between Las Cruces Avenue and Griggs Avenue. The event is scheduled for Friday, August 14, 2015 from 5:00 p.m. to 11:00 p.m. Rio Grande Vineyards & Winery has submitted an application to provide wine for sale and consumption at the event. As part of the approval process, the Liquor Control Act ("LCA") requires the liquor license holder to obtain approval for the use of City property from the Las Cruces City Council.

This matter will come before the City Council as part of its regular meeting on Monday, July 20, 2015, which begins at 1:00 p.m. in the City Council Chambers located at City Hall, 700 North Main Street.

In addition, the LCA prohibits the sale and consumption of alcoholic beverages within 300 feet of a church or school unless a waiver has been granted. A waiver request will be considered by the City Council for approval or disapproval because Casa De Alabanza Church is within 300 feet of a designated alcohol service area near the intersection of Main Street and Griggs Avenue.


