8 At a work session in May, we projected 3% to 4.5% as our cost of funds. We got a rate of 3.18%
9 for total interest cost. We saved \$640,000 of interest expense.

31 GRT for the debt service payment. The fact that we have 2/12th reserve is an indication that we
32 have a fiscally conservative operation and the ability to sustain a AA3 rating.
