To authorize a permitting process to continue.

BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:

The Las Cruces Country Music Festival ("Music Festival") will be held in the Downtown area, on City of Las Cruces property, April 29 and 30, 2016. The City of Las Cruces, through its Convention and Visitors Bureau, is the sponsor of the Music Festival and would like to have alcoholic beverages available for consumption during the event. Consumption of alcoholic beverages would be allowed between the hours of 4:00 p.m. to 12:00 a.m. on each day within a restricted and secured area located generally west of North Church Street and north of Las Cruces Avenue. The Game Sports Bar & Grill, New Mexico Liquor License No. 2733, has submitted a Special Dispenser Permit Application ("Permit Application") to sell and serve the alcoholic beverages.

The Alcohol and Gaming Division of the New Mexico Regulation and Licensing Department ("Alcohol and Gaming") allows an alcoholic beverage license holder, in this case The Game Sports Bar & Grill, to submit a Permit Application to use its Dispenser license at a place other than its regular approved licensed premises. The Las Cruces City Council must grant approval for the issuance of the Permit Application before The Game Sports Bar & Grill sends it to Alcohol and Gaming for review and final approval.

In addition to the Permit Application, Alcohol and Gaming requires a detailed floor plan showing the restricted and secured location of alcoholic beverages including the location of bars, security and the placement of security personnel, serving areas, entrances, exits, and the type and height of the enclosure of the service area which is at least four feet or higher. Finally, Alcohol and Gaming requires a list of employees who are licensed servers for The Game Sports Bar & Grill who may sell and serve the alcoholic beverages.

The authorization of the Public Celebration Permit Application will comply with the requirements of the Las Cruces Municipal Code, Section 5-1, which restricts alcohol consumption in public places only to areas approved by Alcohol and Gaming.

A RESOLUTION AUTHORIZING THE GAME SPORTS BAR & GRILL TO CONTINUE WITH THE PERMITTING PROCESS TO ALLOW FOR THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN A RESTRICTED AND SECURED AREA ON APRIL 29 AND 30, 2016, DURING THE LAS CRUCES COUNTRY MUSIC FESTIVAL.

The City Council is informed that:

WHEREAS, the Las Cruces Country Music Festival ("Music Festival") will be held in the Downtown area on April 29 and 30, 2016; and

WHEREAS, The Game Sports Bar & Grill is requesting approval to sell alcoholic beverages for consumption on April 29 and 30, 2016 in a restricted and secured area during the Music Festival; and

WHEREAS, approval by the Las Cruces City Council is required prior to submission of the Special Dispenser Permit Application to the Alcohol and Gaming Division of the Regulation and Licensing Department of the State of New Mexico ("Alcohol and Gaming"); and

WHEREAS, final approval by Alcohol and Gaming would allow alcoholic beverages to be sold for consumption during the Music Festival between the hours of 4:00 p.m. and 12:00 a.m. on April 29 and 30, 2016; and

WHEREAS, approval of the Special Dispenser Permit Application will also comply with the requirements of the Las Cruces Municipal Code, Section 5-1, which restricts alcohol consumption in public to areas approved by Alcohol and Gaming only.

NOW, THEREFORE, Be it resolved by the governing body of the City of Las Cruces:

(I)

THAT The Game Sports Bar & Grill is hereby authorized to continue with the

permitting process to allow for the sale and consumption of alcoholic beverages within a restricted and secured area on April 29 and 30, 2016 during the Las Cruces Country Music Festival, as shown on Exhibit "A" attached hereto.

(II)

THAT City staff is hereby authorized to do all deeds as necessary in the accomplishment of the herein above.



