**BACKGROUND / KEY ISSUES / CONTRIBUTING FACTORS:**

Pursuant to New Mexico Statutes, no license for the sale of alcoholic beverages shall be issued to a premises that is within 300 feet of a church or school unless the governing body of the local option district grants a waiver of the distance restriction.

Mariscos Boca del Rio y Comida Mexicana ("Mariscos") is approximately 95 feet from Land Mark Church. The property owners within 300 feet of 150 South Solano were notified by U. S. Mail of the City Council meeting to approve or disapprove the waiver and the issuance of the restaurant beer and wine license.

The approval or disapproval of the issuance of the restaurant beer and wine license is presented as a separate agenda item and its approval is contingent upon approval of a waiver of the distance restriction. Granting a waiver of the church/school distance restriction will allow Mariscos to proceed to the next step of the application process.

A RESOLUTION APPROVING THE ISSUANCE OF A WAIVER OF THE CHURCH/SCHOOL DISTANCE RESTRICTION FOR A RESTAURANT BEER AND WINE LICENSE WITH ON PREMISES CONSUMPTION ONLY TO MARISCOS BOCA DEL RIO Y COMIDA MEXICANA, LOCATED AT 150 SOUTH SOLANO, LAS CRUCES, NEW MEXICO.

The City Council is informed that:

**WHEREAS**, according to NMSA 1978, Section 60-6B-10, no license shall be issued for the sale of alcoholic beverages at a licensed premises that is within 300 feet of a church or school; however, in 1997, Section 60-6B-10 was amended to allow for the granting of a waiver of the distance restriction by the local option district governing body for the proposed licensed premises; and

**WHEREAS**, the location of Mariscos Boca del Rio y Comida Mexicana ("Mariscos") at 150 South Solano is approximately 95 feet from Land Mark Church; and

**WHEREAS**, a waiver of the distance restriction is required prior to the approval of the issuance of the restaurant liquor license; and

**WHEREAS**, approving this resolution will allow the applicant to continue with the application process.

**NOW, THEREFORE**, Be it resolved by the governing body of the City of Las Cruces:

(I)

**THAT** the issuance of a waiver of the church/school distance restriction to Mariscos, located at 150 South Solano, Las Cruces, New Mexico, as noted in the letter from Alcohol and Gaming, attached hereto as Exhibit "A", is hereby approved.



**Greetings:**

The Director of the Alcohol and Gaming Division has reviewed the referenced Application and granted **Conditional Preliminary Approval**. It is being forwarded to you for Local Option District approval or disapproval of the Liquor License Application.

While the law states that "within forty-five (45) days after receipt of a Notice from the Alcohol and Gaming Division, the governing body shall hold a Public Hearing in the question of whether the department should approve the proposed issuance or transfer", we recognize the potential for conflict between the requirement for publication of 30 day notice and the 45 day hearing requirement. Should the Local Governing Body be unable to meet one of these requirements, please send a Request for Waiver/Extension by email to the assigned AGD Hearing Officer listed on page 2.

**Notice of the Public Hearing** required by the Liquor Control Act **shall be given by the governing body by publishing a notice** of the date, time, and place of the hearing **twice during the 30 days prior to the hearing** in a newspaper of general circulation within the territorial limits of the governing body. **The first notice must be published at least thirty (30) days before the hearing. Both publications must occur before a hearing can be conducted.** The notice shall include:

- (A) Name and address of the Applicant/Licensee;
- (B) The action proposed to be taken by the Alcohol & Gaming Division;
- (C) The location of the licensed premises.

In addition, if the Local Option District has a website, **the Notice shall also be published on the website.**

The governing body is required to send notice by certified mail to the Applicant of the date, time, and place of the Public Hearing. The governing body may designate a Hearing Officer to conduct the hearing. **A record shall be made of the hearing.**

**THE APPLICANT IS SEEKING A RESTAURANT BEER AND WINE LICENSE WITH ON PREMISE CONSUPTION ONLY. APPLICANT IS REQUESTING A WAIVER FROM THE CITY OF LAS CRUCES AS THE PREMISE IS WITHIN 300 FEET FROM A CHURCH.**



**Within thirty (30) days** after the Public Hearing, the governing body shall notify the Alcohol and Gaming Division of their decision to approve or disapprove the issuance or transfer of the license by signing the enclosed original Page 1 of the Application. The original Page 1 of the Application must be returned together with the notices of publication. **If the Governing Body fails to either approve or disapprove the issuance or transfer of the license within thirty days after the Public Hearing, the Director may issue the license.**

If the Governing Body disapproves the issuance or transfer of the license, it shall notify the Alcohol and Gaming Division within thirty (30) days setting forth the reasons for the disapproval. A copy of the Minutes of the Public Hearing shall be submitted to the Alcohol and Gaming Division with the Notice of Disapproval (*Page 1 of the Application, noting disapproval*).







Mariscos Boca del Rio y Comida Mexicana ("Mariscos"), located at 150 South Solano, has applied to the Alcohol and Gaming Division of the Regulation and Licensing Department of the State of New Mexico for a restaurant beer and wine license with on premises consumption only. As part of the approval process, state law requires the applicant to obtain approval from the City Council.

This matter will come before the City Council as part of its regular meeting on Monday, December 5, 2016, which begins at 1:00 p.m. in the City Council Chambers located at City Hall, 700 North Main Street.

You are being sent this letter because property you own is within 300 feet of the location of Mariscos. State law prohibits the sale and consumption of alcoholic beverages within 300 feet of a church or school unless a waiver has been granted. Land Mark Church is within 300 feet of Mariscos.

If you wish to share your views concerning the beer and wine restaurant license, the waiver request and the application to sell beer and wine, you may attend the City Council Meeting on December 5, 2016, or you may submit your views in writing to the City Attorney's Office, P. O. Box 20000, Las Cruces, New Mexico 88004. Letters must be received by 5:00 p.m. on Thursday, December 1, 2016.
